Departmental Reports – Electronic reports provided to the council. Cemetery Board will be meeting on Wednesday, October 23rd at 4:30pm. A memorial bench for Peggy Johnson will be moved from existing location (out of town) to the city park by the water plant. Officer Roen will be having a Bike Safety Program on November 4th for 3rd & 4th graders and the Junior Deputy Program with Henry County Sheriff's Office will begin on October 30th.

Public Forum-Pam Johnson wanted to confirm that there was nothing that the city needed from the Lions Club in regards to the costume contest on 10/31/24. Rob Quinn voiced his concerns about stray cats in town, curve on south edge of town being slick this winter & painted lines, and the yellow lines on the one-way north of the school on Pine Street.

Wastewater Treatment Plant Updates – HR Green (Matt Wildman)-Matt gave an update on supply delays, blower building should be complete in the next couple weeks, working on connecting lagoon piping, and lift station and liners the week of 10/21/24. Boomerang's schedule still shows operation being complete by December 1st; however, extensions may be needed for items such as seeding, etc. He explained to the council that collecting on liquidated damages (\$500/day) can be tricky.
